- (b) Support and operational direction to the bookeeper, the Treasurer and the Envelope Secretary;
- (c) Support to the Board of Trustees in the execution of its work;
- (d) Oversight and support to the work of any Memorial & Gifts Committee or like group, whether standing or constituted ad hoc;
- (e) Appointing a person to be responsible for financial issues including monthly statement, and oversight and support to the Treasurer; and
- (f) The Treasurer and the Envelope Secretary are members of the Finance committee.
