5. New Business

a. Budget approval

- R. Brain provided a summary of the financial report.
- The 2018 proposed budget was discussed, in comparison to the 2017 budget and preliminary actuals.
- The Thrift Shop revenues continue to exceed forecasts. Increased expenses in the maintenance and janitorial budgets and pulpit/music relief line item.
 Overall, costs are being managed.
- Preliminary figures indicate a total revenue of \$402,359 and expenses of \$342,545 resulting in an operating surplus of \$59,814. Expenses were impacted by lower Ministry & Personnel expenditures due to staff leave.
- The 2018 balanced budget was presented, with total revenue is \$390,000 with expenses at \$389,450, resulting in a surplus of \$550.
- The M&P budget will be emailed to Council and approved by a separate motion.
- Council unanimously approved the following motion (M/S M. Sparks/ K. McKay):

Be it resolved that Mount Seymour United Church Council approve the 2018 budget as presented, subject to the Ministry and Personnel detailed budget is approved at a later date.
